We are searching for outgoing individuals, who have a passion for leading youth through an incredible youth leadership training program in an outdoor setting! Summer camp lasts from early June through late July, and our staff truly becomes a second family.

Requirements:

- Must be at least 21 years of age.
- Must be able to lift and carry 50lbs.
- Must be able to stand and/or walk long hours every day.
- Participates in pre-camp meetings and staff training week.
- Be a registered member of the Boy Scouts of America
- Must be willing to provide year round assistance in planning, creating, and promotion of camp programs.
- Holds current BSA National Camp School Certification in C.O.P.E. course.
- Must possess a thorough knowledge of Project C.O.P.E. aims and methods.
- Must possess a thorough knowledge of C.O.P.E. & Climbing BSA National Standards.
- Current BSA Personal Health & Medical record without restrictions that would limit climbing, challenge course, or high rope events
- Physically fit and able to traverse the C.O.P.E. course without reservation or difficulty.
- First Aid & CPR certified.
 - Meet requirements as outlined in the Boy Scout Resident Camp Standards.

Responsibilities:

- Reports to Program Director.
- Follow rules and guidelines adopted by the C.O.P.E. & Climbing Committee
- Work closely with C.O.P.E. & Climbing Committee to maintain and develop C.O.P.E. program.
- Responsible for keeping a daily log of all Project C.O.P.E. participants.
- Responsible for recruiting participants for Project C.O.P.E. program as campers arrive.
- Follow and enforce current BSA C.O.P.E. & Climbing National Standards.
 - Develop/Alter current policies as needed to maintain a safe, quality program.
 - Deliver the advertised programming from the camp leader/program guide in a safe, efficient, and high quality manner.
 - Work in conjunction with Council COPE/Climbing Committee to develop and execute site specific policies, procedures, and programming.
 - Ensure proper daily visual inspection of all equipment and facilities using the written checklist.
- Perform rescues and initiate emergency procedures as needed.
 - Promote & develop C.O.P.E. program in off season.
 - Responsible for training and managing their Project C.O.P.E. staff thoroughly.
 - Using a written checklist, performs a visual check of the facilities and equipment including hardware and anchor points before each session.
- Responsible for research and ordering all necessary supplies for a safe quality C.O.P.E. program from the Program Director in a timely manner.
- Submits a detailed report on Project C.O.P.E. prior to leaving camp.
 - Teach Staff Initiative Games for use with Scouts.

- Participates in camp wide events.
- Submit a closing report at the end of camp.
- Assume all other duties as assigned by the Program Director, Camp Director.
