Leadership Policy

PROOF OF REGISTRATION OF ALL ADULTS IS REQUIRED BY THE TWO WEEK PRIOR MEETING. UNREGISTERED ADULTS WILL BE TURNED AWAY FROM CAMP ON CHECK-IN DAY, NO EXCEPTIONS. If staying beyond 72 hours, you must have health form C, in addition to A&B. Units are responsible for providing two-deep leadership at all times.

Merit Badges

- Merit badge registration opens April 15, 2024, and is due by June 7. After June 7, any unfilled slots will be open to day program participants. If signing up for a multi-day badge, register for that first to avoid confusion within the system, please.
- Many merit badges require prerequisites. Scouts need to bring in-hand proof of the prerequisites they've completed to show the merit badge counselors for approval.
- We are not a merit badge mill. We offer a wide range of programming and encourage scouts to take full advantage of the fun and adventure of camp. Make memories! It is up to the unit leadership to regulate scouts' schedules to ensure plenty of time for fun and rest, as well as some merit badges.
- Some courses require special equipment such as paper & pen, long pants, boots, phone/camera, laptop computer, Totin Chip, Firemn Chit, Cyber Chip, etc. Please make sure scouts bring these items to camp.

First Day Arrival/Orientation

For your convenience, we have extended arrival time. Your unit may arrive between 10am and noon on Sunday. Orientation will run from 1-4pm, with a leader's meeting in the Dining Hall from 4:00 - 5:00pm. We will also run an emergency drill Sunday evening. Lunch is not provided on Sundays. Scouts will take swim tests if needed. Please send one leader to the camp office to check in all scout/adult medications between 1-4pm. All medications MUST be in their original containers, and scouts should only bring the amount needed to get through the week at camp. If scouts require epi-pens or inhalers, they need to bring 2 (one to keep on themselves, and one to keep in the health lodge).

Showers

Units MUST have an adult present when their scouts are using the shower facility. One key per unit will be issued to an adult leader and should remain in adult possession during the duration of camp.

Food Allergies

It is *absolutely imperative* that all food allergies be communicated to our Kitchen Manager by the twoweek prior meeting, so we have time to make the necessary accommodations. Please complete our Dietary Restrictions Google Form for every person with dietary restrictions /allergies in your unit.

Two Week Prior Meetings

(Camp Coordinators, Scoutmasters, & SPLs encouraged to attend in-person.)

This year, two-week out meetings will be held in person at the AWAC office (8315 W. Jefferson Blvd. Fort Wayne, IN 46804). In order to facilitate and expedite your camp check-in experience, we ask that you bring ALL of the following items with you to this meeting:

- Health forms for all scouts and adults attending camp. (Make sure that all form C's have the required physician's signature, and form A is signed by the parent.)
- Food allergy/dietary restriction Google forms completed for all applicable scouts/scouters in your unit.
- ATV Permission Form & Hold-Harmless Agreements for scouts participating in the ATV program.
- All program fees should be paid prior to this meeting.
- Merit badge sign-up should be completed (by June 7), and your SPL should be prepared to sign up for various opportunities around camp.
- Pre-Camp Swim Check forms with Lifeguard Certification.
- Requests for CPAP battery chargers.
- Registration for adult leadership training and volunteer opportunities.
- Proof of all adults' current YPT training & registration numbers, printed from Scoutbook or your local registrar.

- Ensure all overnight leaders are BSA registered and YPT trained
- Register scouts for merit badges online beginning 4/15.
- Collect all health forms for youth and adults and check for completion
- Dietary restrictions & food allergies form filled out online. See link on pg. 3.
- Final registration payments & program fees to council office or online (\$365/scout if paid by May 1, \$385/scout if paid after May 1) \$155/adult. See p44 for details.)

May

- Plan for visitors at camp.
- Prepare for Gateway Competition.

June

- Attend two-week prior meeting at council office. Bring the following Items:
 - Health forms for all scouts and adults attending camp. (Make sure that all form C's have the required physician's signature, and form A is signed by the parent.)
 - $\circ~\mbox{Food allergy/dietary restriction forms filled out online.}$
 - ATV Permission Form & Hold-Harmless Agreement
 - Payment for remaining fees
 - Merit badge sign-up completed
 - Pre-Camp Swim Check forms with Lifeguard Certification
 - Requests for CPAP battery chargers.
 - Registration for adult leadership training.
 - Proof of adults' current YPT training & registration numbers
- Hold a "shake-down" meeting to ensure all scouts have necessary items packed for camp

NOTE: If you cannot attend the recommended in-person two week prior meeting at the council office, you may mail all of the paperwork listed to our camp office at 2282 W 500 S Pleasant Lake, IN 46779 postmarked by 7 days before your scheduled meeting date, AND attend a meeting via Zoom prior to your arrival date.

Planning for Visitors at Camp

We encourage families to visit their scouts at camp any time. At the end of the week we host Family Friday from 4pm - 10pm so you can see what they've been up to all week! You can enjoy our last open session of the week, explore camp, and experience our closing campfire program with your scout! Please be sure to check-in at the camp office upon arrival at camp, and receive your visitor tag/wristband. You're welcome to eat with your unit that evening as well. Visitor meals are \$10 each and can be purchased before Wednesday night at the camp office by a camp coordinator/ scoutmaster/adult leader. Friday visitor meals CANNOT be purchased day of.

Check-In Day

When You Arrive at Camp

- <u>FIRST</u> Check-In at the camp office between 10am 12pm.
 You will receive a parking pass, camp ID bracelets, and your welcome packet.
- One vehicle & trailer per unit will be allowed to proceed to the campsite at a time. After the first day, all vehicles need to be in the parking lot. No pop-up campers, travel trailers, RV's, personal golf carts, motorcycles, UTV's, or ATV's allowed at camp.
- Set up campsite and *eat lunch by 1pm.*
- At 1pm, Staff Guides will meet you at your campsite to begin your orientation tour. Please bring:
 - bathing suit & towel
 - ° water
 - One leader should bring all medications to the camp office for check in with the health officer.

- 5:30pm Supper rotations begin
 Wear Class A Uniforms
- 6:15pm Flags on the Parade Field
- 7:15pm Emergency Drill
- 7:45 9:30pm Opening Campfire

Preparing for Check-Out

Units are welcome to check-out whenever it is most convenient for them - Friday evening after Closing Campfire or Saturday morning before 11am. Please alert our camp office early in the week, when you plan to leave by signing up for your Commissioner Checkout Inspection Time in the camp office. This will allow us to ensure that your checkout packet, complete with your unit's blue cards and awards are prepared for you when you check out. If you choose to stay through Saturday morning, we have a simple breakfast to offer you at your campsite. Please fill out the appropriate paperwork to let our kitchen staff know how many breakfasts to send to your campsite.

Check Out To Do List: (to be completed throughout the week...)

- Complete Saturday Breakfast Form (even if your unit does not want Saturday breakfast, please turn in your form with zeros, so that we know you haven't forgotten to order your meal.) Turn form in to the kitchen staff, or in the mailbox behind the Dining Hall **by Tuesday**.
- Sign up for your Commissioner Checkout Inspection time slot in the camp office *by Thursday.*
- Check the Lost and Found (outside the Trading Post) often, especially on your last day of camp.
- When your unit is ready to leave camp, please bring the Commissioner Checkout Form, the med box, and the shower keys to the camp office to turn them all in.
- Once everything is turned in, we will provide you with your checkout packet.

1st Year Camper Program

Welcome your new Scouts to camp and to Scouting with the First Year Camper Program "Turtle Quest"!

Two days (Monday & Tuesday) full of fun, laughter, and learning.

Turtle Quest is for new scouts, ages 10-13, who are coming to resident camp for the first time. This is a bridge between Cub Camp (Arrow of Light) and Scout Camp. Scouts will learn and use the Patrol Method, Scout Oath and Law, Scout Spirit, basic Scouting skills, and teamwork through games and activities. This is a fun and exciting experience to help acclimate our newest members.

Upon completion of tasks and competitions, Scouts will earn a special token for their achievements.

This program is a two day program on Monday and Tuesday of resident camp. Scoutmasters are encouraged to join us later in the afternoon on Tuesday to hold Scoutmaster Conferences - camp staff will not be signing books. Although our focus is on learning through fun activities, scouts should have the opportunity to achieve many requirements towards Scout and Tenderfoot ranks upon Scoutmaster review.

We will have our own special campfire on Tuesday evening after vespers, where each scout should bring a buddy as they will come back to their campsites when we are done - leaders are also welcome to attend. Scouts will perform skits with their patrols as a First Year Camper unit and celebrate their hard work over these two days.

Scouts should bring their 10 essentials with them everywhere they go.

Shooting Sports

Truly a favorite among Scouts, all shooting sports - archery, shotgun, and rifle - take place at Cole Shooting Sports. All of these badges require good hand-eye coordination, and are not recommended for first-year scouts. Additional open sessions may be required to complete these badges. All Shooting Sports activities are supervised by a National Camp School Trained Shooting Sports Director and/or NRA Certified Instructor.

Open Archery/Rifle/Shotgun - Open for Scouts and adults to come and shoot rifle, shotgun, and archery. NOTE: Merit Badge participants will have priority during these times. There is no additional cost for rifle or archery. Shotgun costs \$3 for 5 shells, and is payable in the camp office.

Muzzleloader Madness - Have a blast with the muzzleloaders! Open to all ages with no additional costs. Any watermelons found in and around the range on this day are fair targets...

Open Tomahawk & Knife Throwing - Open for Scouts and adults to come and throw 'hawks or knives. NOTE: This is not a merit badge. No age restrictions.

Scout & Scoutmaster Shootout - Send your unit's top shot youth and adult to compete in our Top Shot Competition Thursday at 7pm!

All aquatic merit badges and activities are instructed on our very own Pit Lake. A former rock quarry, its crystal clear waters and sandy bottom make us proud to say that it is one of the cleanest lakes in Indiana! The Aquatics Program is supervised by a National Camp School Certified Aquatics Instructor.

Instructional Swim - This "Learn-To-Swim" program will introduce Scouts who are beginners or learners to swimming. Focus is on developing strokes and swimming proficiency needed to pass the BSA Swimmers Test. NOTE: This is not a merit badge. If scouts are signed up for Swimming MB, and cannot pass the swim test, they will be redirected to this course.

Snorkeling - Not a merit badge, this experience allows you to earn and wear the Snorkeling Award. Participants must have the swimming merit badge and pass the BSA Swimmers Test.

Stand-Up Paddleboard Award - Not a merit badge, this training allows you to earn and wear the SUP Award during Open Session. Participants must pass the BSA Swimmers Test.

ATV - Must be over 14 years old and complete the E-Course at https://atvsafety.org/atv-ecourse/ before camp. **Bring** the completion certificate and hold-harmless agreement & Covid waiver with you to camp, and be prepared to ride (even if only on the waitlist) by having long pants, long sleeve shirt, boots that cover your ankles, and bring a water bottle. There is a \$40 fee for this class, they are offered on Monday, Tuesday, and Wednesday, and class sizes are limited. We will provide ATV, helmet, goggles, and gloves.

This year, we are offering a 2nd year Red Arrow Trail (R.A.T.) ride on Monday only, from 9:00am to 3:30pm, including lunch on the trail. Please pre-register for this ride as you would a class. There is a \$20 fee for the Red Arrow Trail Ride.

All programs in this area require paper and writing utensils.

Search & Rescue (SAR) - Spend the day learning how to find lost/injured persons in the wilderness, then participate in a mock disaster search & rescue event! This badge gained a lot of popularity at camp in 2023! You won't want to miss it!

Most STEAM programs take place in the Grandstaff Lodge just east of the Dining Hall on the parade field. Many of these merit badges require kits that are provided. In addition, some extra time may be needed to finish a project outside of the session time.

Brotherhood Ceremony will be Wednesday night following evening program. This is the opportunity for those eligible (Kiskakon members who have been Ordeal for 6 months) to seal their membership in the Order by taking their Brotherhood. Meet on the porch of the Dining Hall.

OA-Run Campfire will be Wednesday at 9:00pm and includes: Call-Out Ceremony - *All are welcome and encouraged to meet the newest members.* Out of council units should bring a letter from their home lodge that lists eligible candidates.

Re-Dedication Ceremony will take place after the Call-Out Ceremony. All Arrowmen are invited to participate and receive a special patch.

Camp Programs

Trail Awards - The Pokagon-Kekionga Trails Association maintains six marked trails that cover over 35 miles throughout the wilderness at the Anthony Wayne Scout Reservation. All trails begin at the CCLT Parking Lot and are well marked. Trail maps and guides are available through the camp office or the council website. Trail patches and medals are available for purchase through the Trading Post. For more Information go to https://www.ccltbsa.org/pokagon-kekionga-trails

Blue Heron Camper Award - This local council award was started in 1993. Units who earn it for the first time wear the Blue Heron Patch. The second year earns them a white arrowhead pin; the third year a yellow arrowhead pin; and the fourth year the black arrowhead pin. The last pin to earn is the red arrowhead pin. Units who have earned the Blue Heron Award for 5 years are presented an award at the closing campfire. Patches and pins are available for purchase from the Camp Trading Post. Unit leadership is responsible for maintaining records and submitting paperwork to the Camp Director to earn the award each year.

Commissioner Award - Earn this by accumulating a total of 125 points or more for the week. The commissioner staff will inspect every unit Monday through Friday, and they are the final authority on all Commissioner Awards. The Commissioner Award is one of the required items for the Blue Heron Award.

Gateway Competition - The gateway will be scored on the following: correct knots and lashings, scout participation, originality, and creativity. Ribbons will be awarded to all participants. The commissioner staff is responsible for judging gateways. The competition is one of the required items for the Blue Heron Award. Please note that gateways MUST NOT block the camp service road through or to any campsite. Please locate your gateways to the sides of these roads.

Polar Bear Swim - Weather permitting, the waterfront will be open before breakfast on a designated day for a quick dip in Pit Lake. Patches are available in the Camp Trading Post. Participants will need to sign up in advance at the camp office.

Vespers Service - We will hold a camp-wide non-denominational Vesper service on Tuesday evenings at 7:15pm in the Dining Hall. A Catholic prayer service will be held at the same time at the Chapel.

Camp Chief Little Turtle Commissioner Award

American Flag Displayed - Each campsite should display the American Flag. The flag must be properly displayed as indicated in the Boy Scout Handbook. Each campsite is equipped with one flagpole. If more than one unit is in a campsite, then each unit will share the one flag pole. While not mandatory, it is recommended that units display the American Flag at the entrance of their gateway.

Fire-Plan/Duty Roster Posted - Each unit must have a designated fire pit or ring. A fireguard chart must be completed and posted (available at camp office). Each unit/patrol fire area should be in an existing fire ring. A fire bucket with water, and a fire bucket with sand or dirt must be present. Fire buckets and shovels can be requested from the Quartermaster, if the unit does not have them. NO FIRES may be left unattended, and NO FLAMES in tents must be marked on each tent or next to each tent (camp tents are marked). A daily duty roster must be clearly posted in the campsite indicating daily responsibilities of Scouts and patrols. Bulletin boards are available from the Quartermaster, if the unit does not have one.

First-Aid Kit - Each unit should have a First-Aid Kit located in a central and accessible location that is visible from outside the campsite at all times (not locked in a trailer). The kit should contain items to perform basic first-aid procedures. All Injuries requiring first-aid must be reported to the Camp Health Officer. This can be done by filling out the first aid slip.

Axe Yard Properly Marked - Each unit must have an axe yard for scouts. Each axe yard should be well marked and clear of any obstacles. The axe yard should have a gate, place to display Totin' Chip Card, and the chopping block must be secured. All chopping and sawing must be done in the axe yard.

Unit Tools In Proper Place - All unit tools must be stored in a secure location when not in use (a supply tent or unit trailer). Those tools being used during the day in the campsite such as axes and saws must be sheathed and off of the ground.

Grounds Clean - The unit must keep their campsite clean and free of trash, whittling chips, and other materials. All perimeter ropes and gateways must be well maintained and cannot obstruct the camp service road.

Unit Flags Displayed Properly - The unit flag is to be displayed in the ring around the main flagpole. There is a flagpole for every unit flag. Please raise your unit flag during the camp raising ceremony after breakfast, and then retire your flag during the camp flag lowering ceremony. Please do not leave your flag on the pole overnight.

Latrine Clean - The latrine in every campsite must be cleaned and sanitized on a daily basis. The wash stands must have hand soap and hand sanitizer present. Units sharing a campsite must coordinate their cleaning responsibilities. All toilet lids must remain down when not in use. Hoses are NOT to be used to clean latrines. Latrine cleaning kits will be available in the campsite upon arrival. Additional hand soap, hand sanitizer, and cleaning supplies are available through the Quartermaster.

Patrol Method/Scout Spirit - The commissioner staff will be looking for evidence of the patrol method in use by each unit. Evidence of the patrol method/scout spirit may be obtained by observing the patrols in camp-wide activities, campsite, etc.

Camp Gadget - Each unit is encouraged to create a camp gadget that will be useful to them during their week at camp. No grading will be conducted on camp gadgets until Tuesday in order to give scouts time to design and build.

Fire Extinguisher - The unit must keep their campsite (camp provided) fire extinguisher visible for the campsite.

Blue Heron Camper Award

The Blue Heron Camper Award is a great way to keep the Camp Chief Little Turtle Legend alive in your unit! This is a progressive award, recognizing up to five years of camping experience at CCLT. Recognition the first year, consists of the Blue Heron Patch. Each subsequent year earns the colored arrowhead pins to go around the compass of the patch, and then a plaque with the completion of the fifth year. The record of this award is only kept by each individual unit.

To be eligible for the Blue Heron Camper Award, a unit must accomplish the following:

- The unit must accumulate 125 points in their campsite inspections (per the commissioner score sheet).
- The unit must participate in the following camp-wide events:
 - Slip N Slide & COPE Challenge
 - Little Turtle Cup
 - Gateway Competition
- The unit must attend the Camp Vespers/other religious service.
- The unit must complete a camp service project AND a cleaning project as designated by the camp office.
- The unit or a patrol of the unit must teach/lead a song or skit at closing campfire.
- The unit SPL must attend all SPL meetings.
- The unit or patrols of the unit must participate in three of the following:
 - OA Event
 - Trail Hike

We can offer additional training for those interested, if we receive enough advanced notice. Please review the possible trainings below and plan to sign up for your (and your attending adult/eligible youth) choices no later than your two-week prior meeting. If there is enough interest in a class, then we will make every effort to set up the training during your week at camp.

First Aid/CPR/CPRO - American Red Cross CPR/AED training. Must have at least 8 paid registrants to run. There is a \$15 fee to participate, which must be paid by Monday of your chosen camp week.

Leave No Trace - Leave No Trace helps reinforce the mission of the BSA, and reminds us to respect the rights of other users of the outdoors, as well as future generations. Appreciation for our natural environment, and a knowledge of the interrelationships of nature, bolster our respect and reverence toward the environment and nature.

Eagle Project Seminar - A seminar on the Eagle Scout Rank will be conducted by an experienced adult leader. This is a wonderful opportunity to learn about Eagle projects and paperwork by someone with considerable experience.

Trek Safely - Trek Safely covers seven key safety points about trekking, and is recommended for adult leaders organizing any type of trek.

WORKERSHIP PROGRAM and APPLICATION

Since its founding, a primary aim of Scouting has been to teach self-reliance and promote a strong work ethic. Just as important, perhaps, is the goal that no Cub Scout, Scouts BSA Member, Venture Scout, Sea Scout or Explorer be prevented from participating in a Scouting activity because of lack of funds. The Workership program helps us achieve these objectives.

Each year partial Scout camp fees are awarded to those Scouts who wish to go to camp but are unable to pay. Unit Service projects, such as Scouting for Food, do not qualify, nor do service projects completed as part of a Scout's advancement program count for Workership Projects. Projects are recommended to be a minimum of 10 hours with significant effort on the scout's part, appropriate for his age.

Workerships can be awarded for up to 50% of **early bird** camp fee. Workerships are awarded strictly on the "honor system". No proof of income is required, although the program is designed to help a <u>low-income youth</u> who could not otherwise afford to go to camp.

CCLT Pre-Camp Swim Test

Complete the Unit Swim Classification Test. This test must be led by an approved-by-the-Council unit leader, and conducted by a recognized/certified Instructor. Record the results of the Swim Classification test on the form provided. Details on the requirements for the Swim Classification test are found on the back of this sheet. Any Scout not listed on the Unit Swim Classification Test Form will be labeled a non-swimmer until he or she completes a swim classification test at camp. Upon arrival in camp, we will confirm your unit roster, and your unit will be able to proceed with the remaining orientation. Those that have completed the swim test will not need to complete a swim check at camp.

SPECIAL NOTE: When swim test are conducted away from camp, or at the point of activity, the Camp Aquatics Director shall at all times reserve the authority to review or retest all participants to ensure that standards have been maintained.

The following steps must be followed to complete the unit swim classification test prior to camp.

- The swim classification test must be conducted by one of the following individuals: Aquatics Instructor (BSA Camp School trained), Aquatic Supervisor (BSA Camp School trained), BSA Lifeguard, certified lifeguard, swimming instructor, or swim coach. When the unit goes to summer camp, each individual will be issued a buddy tag under direction of the Camp Aquatics Director.
- Attach a copy of the certificate card of certifying instructor, to the unit swim classification record.
- Complete the classification test after January 1, of the summer camp year. (Any illness or injury to a Scout or Scouter between the swim test and camp needs to be addressed at camp.)
- Bring unit swim classification record to the two-week prior meeting.

Swim Classification Procedures

The swim classification of individuals participating in a Boy Scout of America activity is a key element in both Safe Swim Defense and Safety Afloat. The swim classification tests should be renewed annually, and no more than 6 months prior to summer camp.

All persons participating in BSA aquatics are classified according to swimming ability. The classification tests and test procedures have been developed and structured to demonstrate a skill level consistent with the circumstances in which the individual will be in the water. The Swimmer's Test demonstrates the minimum level of swimming ability for recreational and instructional activity In a confined body of water with a maximum 12-foot depth, and with shallow water footing, or a pool or pier edge always within 25 feet of the swimmer. The various components of each test evaluate the several skills essential to the minimum level of swimming ability. Each step of the test is important, and should be followed as outlined below:

Swimmer's Test - Jump feet first into water over the head in depth, level off, and begin swimming. Swim 75 yards in a strong manner, using one or more of the following strokes: breast stroke, trudgen, or crawl; then swim 25 yards using an easy resting back stroke. The 100 yards must be swum continuously, and include at least one sharp turn. After completing the swim, rest by floating.

Lost and Found: Most lost and found items will be kept outside of the Trading Post, while valuable items will be kept at the camp office. AWAC is not responsible for any unit or personal items that may be lost, stolen, or damaged. Items are disposed of one week after each camp session.

Visitor Policy: We encourage families to visit their campers at camp and explore our facility! You're welcome to visit any time of the week, but we especially invite you to join us for Family Friday. All visitors must sign in and receive a visitor tag/ bracelet at the camp office. If you need meals during your visit, you can purchase those for \$10/meal ahead of time through your camp coordinator/scoutmaster/adult leader. Friday visitor meals MUST be purchased in advance so that our kitchen has time to prepare.

Personal Bikes: Personal bikes may be used on our trails at camp and to travel to and from merit badges. Units are responsible for transporting them to and from camp. CCLT is not responsible for personal bikes used for program. Helmets and shoes must be worn at all times.

Fireworks/Firearms: Personal firearms, fireworks, ammunition, and bow hunting equipment are strictly prohibited. Sheath knives used as camp tools may be used by adults 18 years and older, NOT by youth.

Campfire Policy:

Fire Rings: All fires must be burned in a fire ring. No materials are to be burned outside of the fire ring. Fire rings and firewood will be provided by the Anthony Wayne Scout Reservation.

Fuel: Only wood provided by the Scout Reservation (with the exception of kiln dried lumber) is to be burned at camp. Liquid fuels (white gas, lantern fuel, lighter fluid, etc.) must be stored in a ventilated, locking box a minimum of 20 feet from all buildings, tents, and open flames.

Area and Safety Considerations: Units must complete and follow the Fireguard Plan. Plan will be provided upon arrival. It is recommended that an area of 10 feet around the fire ring area be checked for and cleared of flammable debris.

Personal Gear: A suggested list of personal gear can be found on page 45. Everything you need can easily be packed in a backpack or duffel bag. The less you bring, the easier it is to transport to your campsite. Scouts should bring at least two pairs of shoes, including one pair of hiking boots/shoes. All personal gear should be marked with the Scout's name and unit number.

Camp Housing: CCLT provides tented and non-tented sites. Tented sites have BSA wall tents, designed for two scouts or adults. Tents stand on a wood platform and include cots, mattresses, and mosquito netting. Each site has latrine facilities, a wash stand, and a flagpole. Camp management reserves the right to re-assign campsites and units. All units should plan on sharing the site with other units as there are multiple unit sites in each campsite.

Camp Showers: Located near Shawnee campsite. Units MUST have an adult present when their scouts are using the facility. Adults and scouts are responsible for keeping the shower house and restrooms in good order. One key per unit will be issued to an adult leader. If more keys are needed, please see the camp office.

Cell Phone Policy: Cell phone usage during program time is at the discretion of the Counselor. Outside of program it is up to unit leaders. Some merit badges do require the use of electronics, such as a camera, the camera on a cell phone, and/or a laptop computer. Please see the Merit Badge Quick Reference Guide to make sure your scout comes prepared.

BSA Rules and Policies: CCLT complies with and enforces all BSA rules, policies, and procedures. A complete list of National BSA policies can be found in the Guide to Safe Scouting, or at www.scouting.org.

Vehicles In Camp: One vehicle per unit at a time ON CHECK-IN DAY ONLY. Each unit is allowed one trailer in the campsite. DO NOT transport anyone outside the passenger cab of your vehicle at any time. Everyone riding in a vehicle MUST have and wear a seat belt at all times.

Emergency Plans: Detailed plans have been developed to handle emergencies that may arise at camp. Details about these plans will be made available to leaders upon arrival at camp. Unit leaders are encouraged to leave their cell phone number at the camp office in case we need to contact someone from the unit.

Drugs/Alcohol/Smoking: Alcohol and illicit drugs are strictly prohibited. Violators will be removed from camp by the Steuben County Sheriff's Department. All medications MUST be kept in the lockable med box provided by CCLT. Adults are not permitted by BSA Policy to smoke or vape in front of Scouts at any time. Please consult the camp office for designated smoking areas.

Medication Lock Box Procedures

- Upon arrival at camp, all medications will be reviewed by the Health Officer during check-in of unit physicals. Medication not requiring refrigeration or temperature controlled storage will be placed in a medication box (camp provided), a lockable storage container to be kept at the unit's campsite.
- Each unit will have a Unit Leader who will be assigned a key to the medication box.
- Medication boxes must be store in a locked location, such as a unit trailer or leader vehicle.
- Each day the Unit Leader will complete the Medication Distribution Log. This log will be reviewed by the Health Officer periodically throughout the week.
- At check-out, all medications must be returned to the scout(s) from both the campsite medication box and the Health Officer. All medication boxes and Medication Administration Records must be returned to the Health Officer.

ALL medications MUST be in their ORIGINAL container. Medication not provided in their original container will NOT be accepted. Please only bring the amount of medication needed to get through the week. Scouts on medications must have a completed medication record sheet signed by their parent upon arrival. Those with Epi-pens, inhalers, etc. should bring TWO marked with the scout's full name. An extra shall be kept in the medication box as a precaution. Medications needing refrigerations will be kept in the Health Office.

Special Accomodations:

- **Electrical Needs:** All scouts and scouters needing electricity for medical assisted devices need to notify the council by your two-week out meeting. Camp can provide battery charging in the camp office during the day with your provided battery. No electricity is available at the campsites.
- Dietary Needs: All scouts and scouters having special dietary needs and allergies should complete and submit the Dietary Restrictions Form by scanning the QR Code on pg. 3 of this guide. The kitchen staff will take these needs under advisement, and contact you with any necessary questions. Email dietary needs and questions to the Kitchen Manager at cclt.kitchen@gmail.com.
- Accessible Transportation: If you require assistance, you must contact the Council Office prior to camp. No personal ATV's, UTV's, or golf carts are permitted.

Reference Guide

Camp Security: ALL campers, leaders, and visitors must check-in AND out of camp at the camp office. It is strongly recommended that scouts do not leave camp. All authorized participants are identifiable by a provided wristband. Visitors will be identified with a "visitor tag", and staff will wear appropriate identifying markings. Unauthorized persons are to be reported to the camp office immediately.

Early Release Policy: Any person needing to leave camp outside of the regular check-in/out time, must do so at the camp office. Any person under the age of 18 must have written consent from their parent/legal guardian on file in the camp office if they need to leave with another adult. This form is available in Part A of page 1 of the annual health form.

Medical Form: The Annual Health Form (Form #680-001, 2019 printing) requires an annual physical by youth and adults regardless of age, and signature of a licensed healthcare practitioner. These forms need to be turned in at the two-week prior meeting for every person attending camp. Please keep a copy for your files. Everyone attending CCLT overnight (scouts and adults) must turn in a health history before participating in any camp activities.

The Annual Health and Medical Record is valid for 12 months, and Parts A, B, and C must be completed for all persons attending camp for a length of 72 consecutive hours or longer. Parts A and B must be completed for all persons staying overnight at camp for less than 72 consecutive hours. UNDER NO CIRCUMSTANCE WILL A MEDICAL FORM BE ACCEPTED BY THE CAMP PERSONNEL WITHOUT THE SIGNATURE OF A LICENSED PRACTITIONER (MD, DO, Nurse Practitioner, or Physicians Assistant) for persons staying at camp for more than 72 consecutive hours.

MEDICAL EXAMS WILL NOT BE PROVIDED AT CAMP.

First Aid: The camp provides a Health Officer on-call 24 hours a day. All injuries requiring additional treatment will be sent to Cameron Memorial Hospital. According to BSA policy, the camp must insure that injuries receive full medical attention in a timely manner. The camp will notify parents if additional treatment is required. ALL injuries (no matter how small) must be reported to the camp Health Officer.

Illness: When a scout or scouter's health is in question prior to their arrival at camp, it is better for them to delay their trip to camp. If any camper becomes ill during camp, it must be reported to the Health Officer. If a scout becomes too ill to participate in the program, or is potentially contagious, their parents will be contacted regarding transportation home. The Camp Health Officer and Camp Director may ask ill scouts and scouters to leave camp in order to prevent the spread of illness.

Incident Reports and Medical Bills

The Boy Scouts of America medical insurance does not automatically cover medical bills.

- 1. The Unit Leader must complete an Incident Report Form with the camp medical staff.
- 2. All medical bills must be submitted to the person's family insurance.
- 3. Any portion not covered by the family insurance may be submitted to the BSA insurance by providing all medical bills and insurance statements to the Anthony Wayne Area Council. The Boy Scouts of America medical insurance is a secondary insurance coverage. It is primary coverage for those members without medical Insurance.

Camp Fee Schedule: The following payment schedule will be used for Scout Resident Summer Camp. Scouts and adults must register and make payments through their unit Summer Camp Coordinator. Units are responsible for making all payments to the council.

Scout Camper \$365 if paid by May 1. \$385 if paid after May 1. Adult \$155 or \$25/Day

Patrol Sites \$100 deposit per unit (due with reservation). Each tented site includes 5 wall tents on a wood platform with two cots and mattresses. Deposit is credited to your final balance.

Multi-Week Discount: A scout may attend additional sessions for \$290.

Early Bird deposits of \$75/scout are due by March 15, 2024, AND the remaining fee of \$290/scout paid by May 1, 2024 (\$310/scout if paid after May 1). Include names of scouts attending. Newly registered scouts and AOL crossovers are \$365 if paid In full by May 1, 2024. Please indicate the number of AOL graduates and new scouts you will be signing up for camp on all signup sheets and online registration.

Program Fees: Camp fees cover the cost of attending camp. Your scouts will want to have some extra spending money for Trading Post souvenirs. In addition, some merit badges require additional kits/fees to be purchased or paid with your registration.

Workership: Workerships are awarded to scouts needing financial assistance (AWAC scouts only). Applications are due no later than May 1 for Scouts BSA and June 1 for Cubs. Applications will be reviewed by the Council Camping Committee. Units and families will be notified prior to payment deadlines.


